THIS ACTION was heard over several days between October 7-16, 2024, with a jury, at 330 University Avenue, Toronto, Ontario, in the presence of counsel for all parties.

October 16, 2024, the jury delivered its verdict that the Defendant, Melanie Solomon, had not satisfied the jury that the accident was not caused by any negligence or improper conduct on her part; and ascribed liability as follows: 66%

to the Defendant, Melanie Solomon, and 34% to the Plaintiff, Vasilios Karadimas.

ON READING the Judgment of the Honourable Mr. Justice Stevenson dated September 23, 2024 (issued on September 25, 2024) approving the Plaintiffs' Agreement on Damages with Aviva Insurance, the Defendant's primary insurer; upon being advised of the parties' agreement on legal costs; and the approval of the solicitor-client account to be rendered to the Plaintiffs by their lawyers, pursuant to rule 7.08 of the *Rules of Civil Procedure*, to be addressed by way of a separate Judgment of this Honourable Court,

- THIS COURT ORDERS AND ADJUDGES that the Defendant shall pay to the Plaintiffs damages in the amount of \$1,000,000.00.
- THIS COURT FURTHER ORDERS AND ADJUDGES that the Defendant shall pay to the Plaintiffs legal costs as follows, totalling \$425,000.00:
  - a. \$326,350.32 for partial indemnity fees;
  - b. \$42,425.54 for H.S.T. on partial indemnity fees;
  - c. \$56,224.14, inclusive of applicable H.S.T., for disbursements.
